## Dear Resident or Property Owner:

San Diego Gas & Electric® Company's (SDG&E®) highest priority is providing you with safe and reliable natural gas and electric service. As part of our commitment to you, we need to make improvements to our electric power lines that connect to SDG&E's Granite Substation to enhance electric system reliability and resiliency in your community.

SDG&E is planning to begin construction on approximately 2.5 miles of a new 69kV underground transmission line in the City of El Cajon and the County of San Diego. Construction activities associated with this work may include, but not limited to, underground trenching work on local streets, work crews and work vehicles in the street, installation of a cable pole, and minor overhead wire stringing work.

## Granite Loop-In TL632-TL6985 Project Details\*:

**Anticipated Schedule:** Early August 2025 through approximately Q2/Q3 2026. Construction in front

of your residence or business is expected to last several weeks to more than a

month.

**Location:** East side entrance from SDG&E's Granite Substation on Naranca Ave and

Terra Lane, south along Terra Lane to E. Madison Ave, east along E. Madison Ave and continuing onto Cerro Sereno and ending on Camino Monte Sombra,

just before Calle De La Sierra, at SDG&E's power line corridor.

Workdays and Hours: City of El Cajon:

Monday – Friday from 8:30 a.m. – 3:30 p.m.; with the potential for extended work hours, night work or weekend work, when needed and permissible.

**County of San Diego:** 

Monday – Friday from 8:00 a.m. – 4:00 p.m.; with the potential for extended work hours, night work or weekend work, when needed and permissible.

\*NOTE: Construction dates and hours are subject to change according to compliance requirements, inclement weather and other unforeseen circumstances.

## What to Expect:

Traffic lanes on the streets described above may require lane reductions, closures and/or detours near the construction area during approved work hours. Flaggers and/or traffic control signs will help manage the flow of traffic. Construction is designed to allow for ingress and egress access to homes and businesses. Additionally, temporary "No Parking" may be in effect for certain areas and will be posted with signs. For your safety and the safety of others, please follow all posted signs and markers.

Construction activities may take place in phases and may occur intermittently with the possibility of multiple construction locations and activities taking place simultaneously, when permitted. Steel plates will cover the affected construction areas as necessary until the work is completed and the impacted area is restored.

Traffic delays are anticipated, and noise and dust disturbances may increase due to work activities. Work hours, traffic control measures, and noise restrictions are established by local jurisdictions. SDG&E will work closely with local municipalities to safeguard a smooth construction process and work crews will strive to minimize impacts from construction activities to the extent possible. We encourage you to adjust commuting plans as necessary.

**Landlords/Property Owners with Tenants:** If the SDG&E bill is in your name, it is your responsibility to notify tenants of any planned work activity.
