SDG&E®: Bundled Electric Rate Change Alert

In May 2025, San Diego Gas & Electric® (SDG&E®) filed [Advice Letter 4653-E](#) revising electric rates to reflect increased costs to operate its electric transmission system. As a result, SDG&E's bundled residential average electric rates will increase by approximately 1.9 cents/kWh or 4.8% from 39.7 cents/kWh to 41.5 cents/kWh.¹

A bundled customer is one who receives both their electric delivery and electric generation from SDG&E. Average residential monthly bill impacts for a typical bundled customer are shown below.

This rate increase reflects SDG&E's request with the Federal Energy Regulatory Commission (FERC) to update electric transmission rates.⁴ Transmission rates cover the cost of moving electricity from power plants to local substations through high-voltage power lines. The requested rate increases went into effect on June 1, 2025. They may be adjusted after a thorough review is completed by FERC.

- Continued delivery of safe and reliable electric service,
- Ongoing investment in transmission infrastructure, and
- An increased return on equity due to increased wildfire risks in California.

SDG&E®: Unbundled Electric Rate Change Alert

In May 2025, San Diego Gas & Electric® (SDG&E®) filed [Advice Letter 4653-E](#) revising electric rates to reflect increased costs to operate its electric transmission system. As a result, SDG&E's residential average electric delivery rates will increase by approximately 1.9 cents/kWh or 7.9% from 23.9 cents/kWh to 25.8 cents/kWh.¹

An unbundled customer is someone who receives their electric generation from another provider such as a Community Choice Aggregator (CCA). For additional information on your electric generation rate, please reach out to your electricity provider.² Average residential monthly bill impacts for a typical unbundled customer are shown below.
