Dear Resident or Property Owner:

San Diego Gas and Electric (SDG&E®) is committed to providing safe and reliable energy. To achieve this, we make improvements to our electrical system. The Streamview Substation Expansion project includes 12kV Underground construction work that will start in approximately late April 2025. This work is necessary to ensure that the reliability of our electric distribution systems meet current engineering standards, accommodate load growth, and improve system safety and efficiency in SDG&E's service territory. The project will achieve the objectives of providing additional capacity to serve existing area load with future customer-driven electrical growth and enhance the distribution and power network to minimize the potential for long-term unplanned outages or service disruptions to area residents and businesses.

SDG&E will begin this segment of the project by performing civil work and install new underground circuit facilities on University Avenue between 47th Street and Euclid Avenue. Planned work will continue onto Euclid Avenue from University Avenue to Orange Avenue, navigating on Orange Avenue between Euclid and 47th Street.

The scope of the upcoming work includes trench and conduit installation in the City of San Diego's public streets. Some public parking and sidewalk access may be unavailable during this section of the project, as permitted by the City of San Diego to allow for safe construction access while reducing traffic congestion. At the conclusion of this work, the work area shall be left in a clean and safe state with no remaining exposure risks. Some moderate noise is expected; trenching equipment, light machinery and power tools will primarily be used for this phase of the project.

Location: City of San Diego streets including University Avenue between 47th Street & Euclid Avenue; Euclid Avenue between University Avenue & Orange Avenue; Orange Avenue between 47th Street & Euclid Avenue.

NIGHT HOURS: The City of San Diego is requiring the work at the above location be performed at night.

NIGHT HOURS: 9:00 p.m. to 5:00 a.m., Sunday evenings to Friday mornings*

Work Days: Sunday to Friday
Start Date: Late April 2025 (*weather permitting*)
Duration: Approximately 5 months



SDG&E will work closely with local municipalities and community groups to ensure construction activities are as least disruptive as possible. Modest noise and dust disturbances may increase due to construction activities. We will keep communities informed during all phases of the project. We're committed to working with you and local public safety officials to help reduce inconveniences and safeguard a smooth construction process.
