Schedule TOU-ELEC is SDG&E's residential rate with a basic service fee for all residential customers who meet one or more of the following criteria: 1) require service for charging of a currently registered Motor Vehicle, as defined by the California Motor Vehicle Code, which is: a) a battery electric vehicle (BEV) or plug-in hybrid electric vehicle (PHEV) recharged via a recharging outlet at the customer's premises; or b) a natural gas vehicle (NGV) refueled via a home refueling appliance (HRA) at the customer's premises; 2) have a behind-themeter energy storage device that is interconnected through Electric Rule 21; or 3) have an electric heat pump for water heating or climate control.
