## Service for Residential Customers with Electric Vehicles

SDG&E provides additional options available for residential customers with electric vehicles. Schedule EV-TOU-5 CPP is SDG&E's residential rate with a basic service fee for customers with an electric car or who use electricity to run a natural gas home fueling pump. The car must be registered with the California Department of Motor Vehicles. This schedule provides a time-of-use option for residential customers who also choose to manage their electric costs by reducing their use when an event is called.

## Schedule EV-TOU-5 CPP - DOMESTIC TIME-OF-USE FOR HOUSEHOLDS WITH ELECTRIC VEHICLES provides domestic residential service for customers who own qualifying electric vehicles. Effective 6/1/2025
